**Dave Burkland, Chair**, has served on CHIP's Board of Directors for two years, but his relationship with CHIP is far from new. He started working at CHIP in 1983.

In 1975, Dave moved to Chico to attend Chico State, earning a degree in geography planning and later receiving a master's in planning. He worked in construction during and after college. He then spent nine years working for CHIP as the corporate contractor and then managing the housing rehabilitation program. Dave worked for and retired from the City of Chico Housing Department after that, and returned as a board member in retirement. He is passionate about helping CHIP remain financially stable continue its mission to develop affordable self-help housing and provide housing-related and social services to residents living at our rental properties.

As mayor and a council member Andy consistently supported low-income housing programs, inclusive planning and support services for CHIP's clientele and the community at large. After leaving the City Council, Andy was able to formally reconnect with CHIP as a Board Member, and in that capacity continue working for and supporting CHIP and the communities it serves. Andy also serves on the City of Chico Arts Commission.

**Mark Hooper** grew up in rural New York, spending summers in Maine and one memorable summer in Idaho.
