Project-based Section 8 vouchers are available. Apply directly with the Housing Authority of the County of Butte.

Tenant-Based/Housing Choice Section 8 vouchers are also accepted.

OCCUPANCY STANDARDS

1 Bedroom 1-3 persons
2 Bedroom 2-5 persons
3 Bedroom 4-7 persons

Exceptions considered with approved Reasonable Accommodation.

ABILITY TO PAY

Applicants must demonstrate ability to pay rent. This can be done by having one of the following:

- Minimum monthly income of two times the rent
- Rental Assistance (i.e. Section 8, TBRA, or other)
- Verification of having paid same rent or more for at least 12 months
